2009 Mileage Contest Classes and Rules



Bike Classes:

1. **FLT Touring (FLH, FLT):** Men's / Women's which includes bikes with fairings and/or hard saddlebags (factory equipped). Dressers: Standard, Classic and Ultra, Road King, Road Glide and Police Bikes.
2. **Sidecar / Trike:** Men's / Women's
3. **Big Twin (FXD, FXR):** Men's / Women's FXR and Dyna, includes all rubber mount Low Rider, Super Glide, Convertible, etc.
4. **Softail (FLS, FXS):** Men's / Women's Heritage, Springer, Fat Boy, Softail Customs and Deuce, etc.
5. **Sportster (XL):** Men's / Women's 883's and 1200's
6. **V-Rod (VRS):** Men's / Women's
7. **Super Mileage:** Any bike over 40,000 miles (one winner)

Contest Rules

1. Contest starts on January 1st.
2. Final mileage must be turned in no later than regular December Chapter meeting.
3. A board member or employee of Earl Small's must verify the beginning and ending mileage
4. You must turn in original form to qualify.
5. If you purchase a new bike during the year and it is in the same class, the mileage can be combined.
6. You may enter more than one class if you have more than one bike or if you change class during the year.
7. If you participated in last year's mileage contest, the starting mileage will be your bike's ending mileage from the previous year.
8. Only one bike per entry unless you have traded or sold your previous bike. Bikes must be in the same class.
9. You must attend a minimum of **6 chapter events** to be eligible to win.
